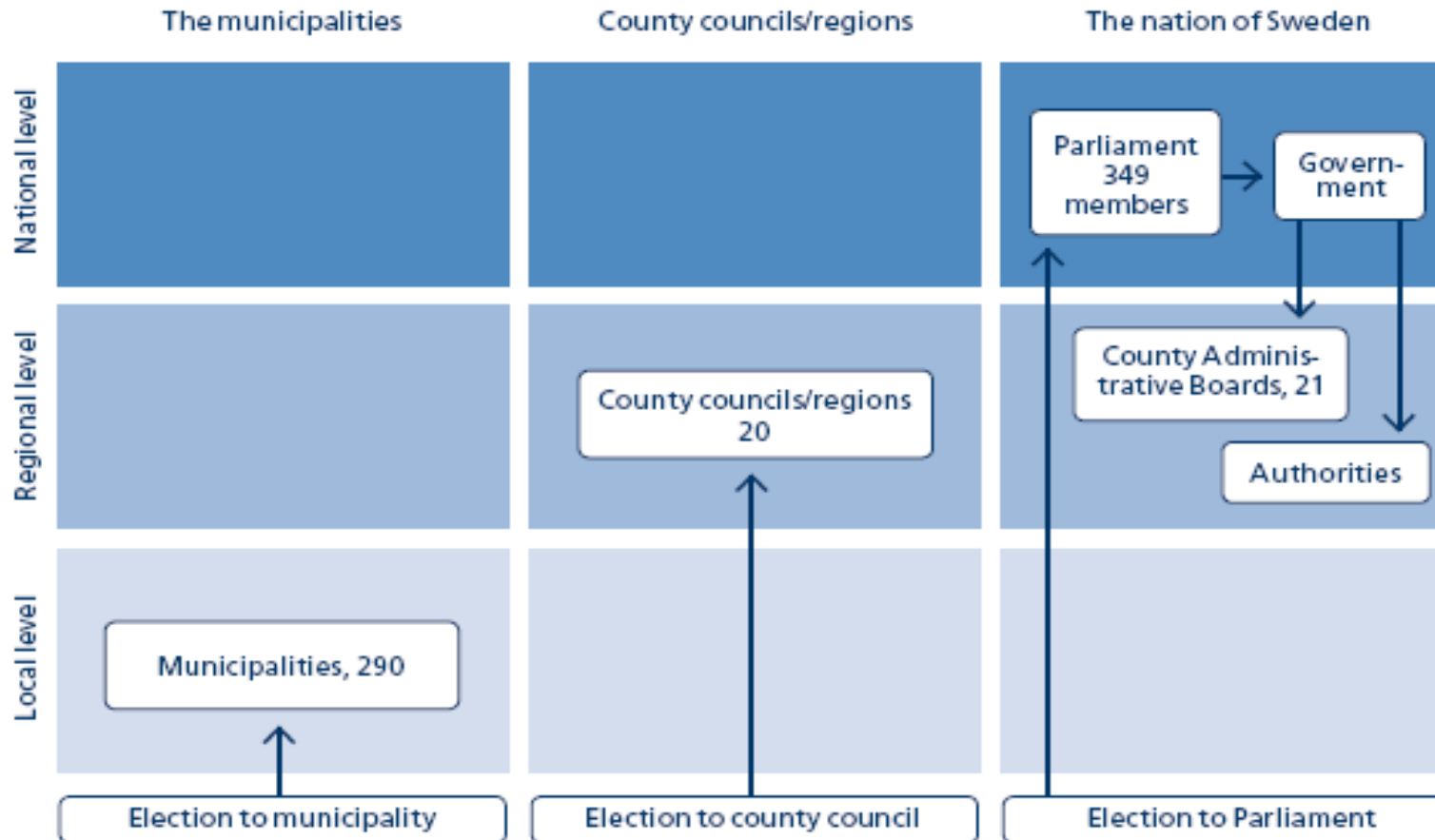

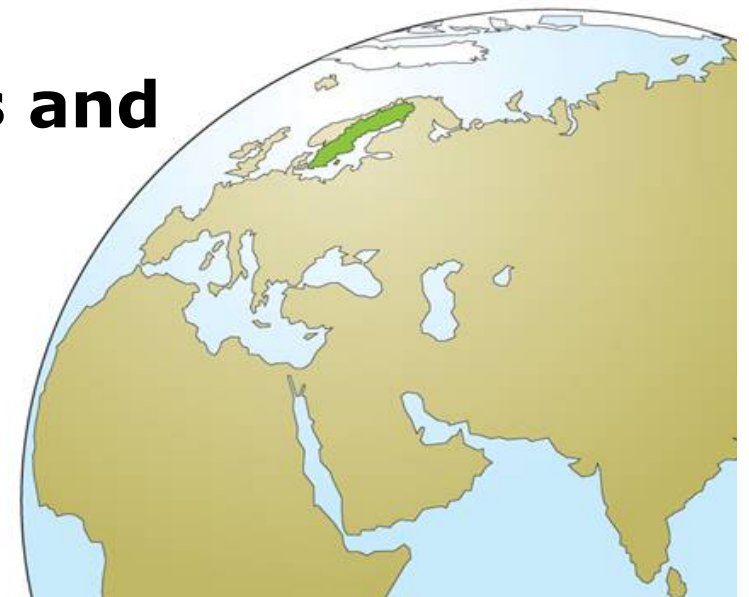

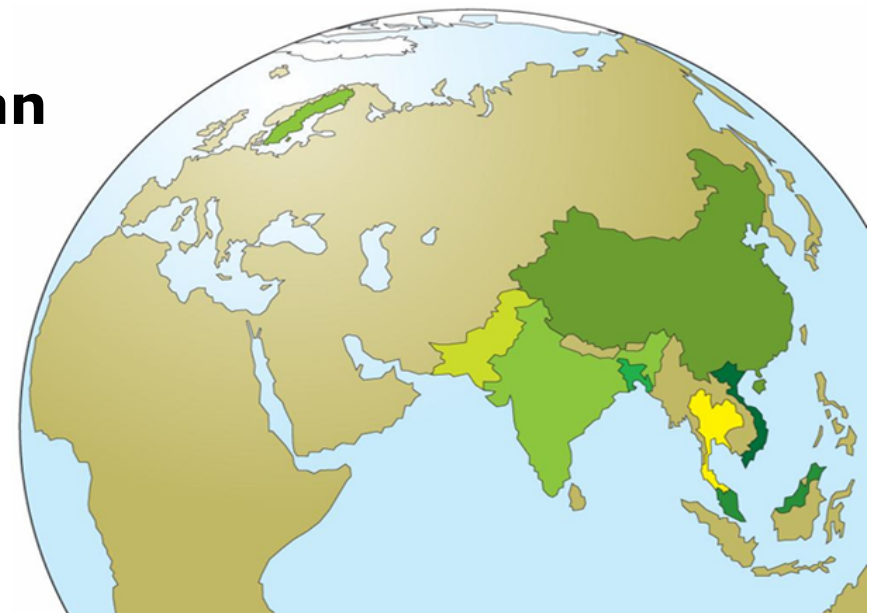
Code of Conduct

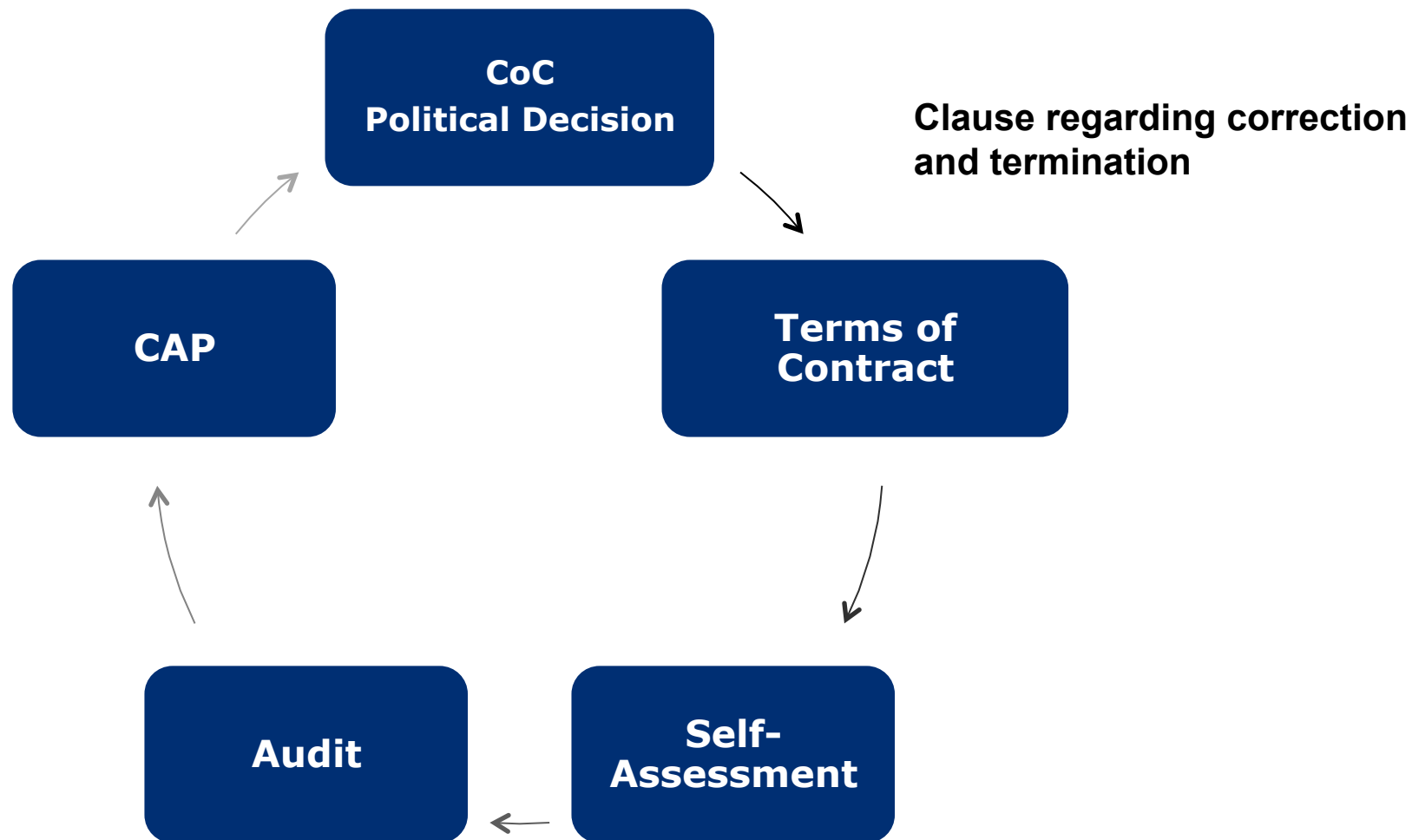

Lessons Learned

A cooperation between the county councils in Sweden

- Large administrative burden
- Not sufficient number of follow-ups
- Not a transparent way of follow-up
- Need to improve skills and competence
(mapping of suppliers, due-diligence on HR, anti-corruption, who audit the auditors)

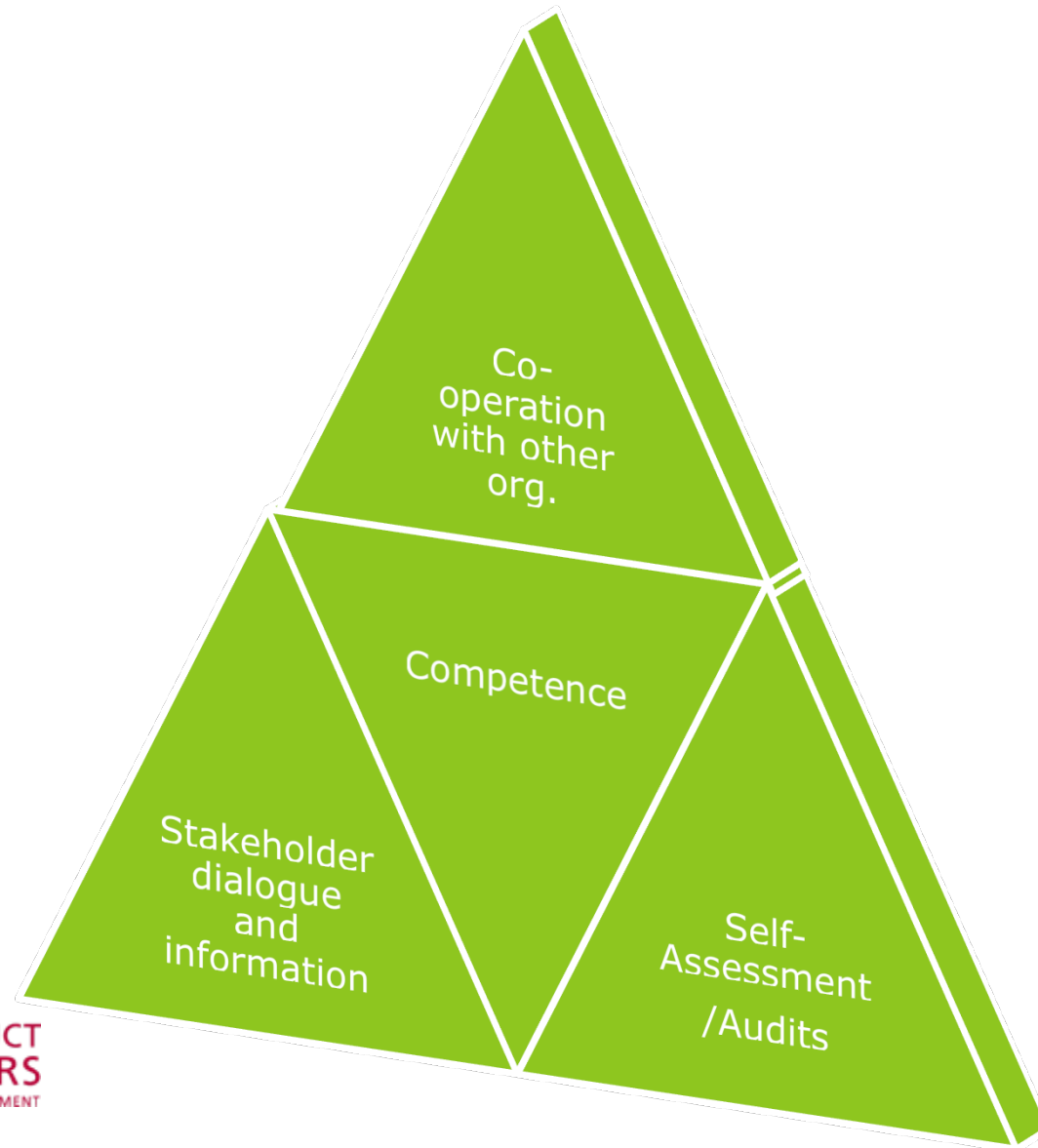
